IMPROVED CONEY STREET RIVERSIDE VISION REVEALED

Following collaborative discussions with City of York Council and close consultation with key stakeholders across the city, including important feedback from the public, we are pleased to have submitted revised plans for our Coney Street Riverside masterplan.

We have made a number of positive changes to the plans including a significant increase in the amount of public realm, improved accessibility and several enhanced building designs.

The masterplan includes the creation of 250,000 sq ft of mixed-use retail, leisure, commercial and residential space, a riverside walkway and the establishment of significant green and accessible public realm, both on the waterfront itself and also through the creation of new access routes between Coney Street and the River Ouse.

The revised application follows an original planning applications setting out Helmsley's vision for Coney Street Riverside, with a decision yet to be reached by City of York Council.

Max Reeves, development director at Helmsley Group, said: "Having worked closely with key stakeholders in York over the past few months, we have been heartened by the positive response we have had to our plans for Coney Street Riverside.

"These include the public benefits of bringing underutilised upper floors of retail unit back into use, a long-held ambition in York, whilst also creating world class public realm fit for this prime location on York's riverfront.

"We have consulted extensively across the city with heritage bodies, Council planners, York residents, accessibility groups and beyond. We'd encourage everyone to look at our proposals, which are publicly available on the City of York





Council planning portal and our own dedicated <u>Coney Street</u> <u>Riverside website</u>, to discover more about the positive transformation we are looking to provide on both the riverfront and Coney Street itself."

Max added: "As a long-established York business, we are committed to creating a truly mixed-use, vibrant development that not only sustainably redevelops historic Coney Street into the social heart of York, but creates a positive legacy through first class public realm of international standing, and architecture which ensures that the history and heritage of the area is not just recognised, but honoured and protected.

"We believe the improvements we have put forward positively build on our long-held ambition to reconnect Coney Street with its riverfront, improving connectivity and accessibility within central York alongside a welcoming, family friendly offer and muchneeded accommodation to meet student demand within the city."

The project team for the scheme includes Helmsley Group, Brown & Co, O'Neill Associates, Corstorphine and Wright, Montagu Evans, Aspect4, Gillespies, Troup Bywaters & Anders, Billinghurst George & Partners, Jane Simpson Access, Knight Frank, DS Emotion and Aberfield Communications.



Key changes proposed to the masterplan include:

- Redesigned public realm throughout the scheme, including significant increases in the amount of public space on the riverfront.
- Increased active retail frontage across the scheme.
- A reduction in some of the proposed buildings' shapes and sizes, as well as moving some of the buildings further away from the river edge to improve the overall quality of the scheme.
- Improved accessibility across the development.



PLANS TO CONVERT HOLIDAY LETS AND BOOST RESIDENTIAL PROPERTY OFFERING IN YORK CITY CENTRE SUBMITTED

Having submitted plans to convert three upper floor holiday lets on York's Spurriergate into residential properties, Helmsley Group is keen to progress with the creation of more residential property in the heart of York.

The application proposes the change of use of the first, second and third floor properties at 22-24 Spurriergate from holiday apartments into three two-bedroomed residential apartments.


The proposal forms part of our strategy to give people home ownership in the city centre and benefit the local economy. In addition to the Spurriergate change of use, Helmsley Group has plans for further conversions and development across its York city centre portfolio, including in upper floors on neighbouring Coney Street as part of its Coney Street Riverside masterplan as well as schemes on King's Square, High Ousegate and Goodramgate.

Tom Riddolls, development surveyor at Helmsley Group, said: "Whilst we are acutely aware of the challenges around planning for permanent residential accommodation in York, particularly due to factors such as bins and bicycle storage. We are committed to providing a mix of uses in the city centre, of which residential is a key part.



On these types of projects, we are often working within the limitations of listed buildings, which can be a significant challenge, however these constraints can also lead to development of characterful and unique properties."

Helmsley Group has a strong track record of residential development in York, including the recent conversion of The Old Fire Station and numerous other city centre residential schemes.



of all ages. Founded in 1973, and with a further pipeline of openings planned, it will boast more than 270 stores across Europe. The Coach House is the brand's first York store.

The retailer, which has taken almost 5,000 sq ft of open-plan floor space at The Coach House, recently opened a store in Sheffield, with other branches in major cities including Manchester, Chester, Derby and London.

After established bar and restaurant operator The Alchemist pulled out of an agreement to move into The Coach House earlier this year due to conditions placed on it by City of York Council's licensing committee, Søstrene Grene's arrival is an exciting prospect.

Søstrene Grene is the latest of several prominent high street and independent leisure and retail operators to join the area in recent times, including Rosa's Thai.


